YARD SALE ORDINANCE

ARTICLE I.
SECTION 13 6

BE IT ORDAINED BY THE CITY COUNCIL, IN COUNCIL DULY ASSEMBLED, AT CHESNEE, SOUTH CAROLINA.

SECTION 1. WHEREAS, THE CITY COUNCIL OF THE CITY OF CHESNEE PROPOSES THE FOLLOWING REGULATIONS SHALL BE FOLLOWED IN HOLDING YARD SALES INSIDE THE CITY LIMITS OF CHESNEE:

(1) ONLY TWO YARD SALES WILL BE ALLOWED BY ONE FAMILY DURING A YEAR WITHIN THE CITY LIMITS OF CHESNEE.

(2) EACH PERSON HOLDING A YARD SALE INSIDE THE CITY LIMITS MUST OBTAIN A PERMIT FROM THE CLERK'S OFFICE AT CITY HALL PRIOR TO THE SALE, AND MUST PAY A \$5.00 FEE.

SECTION 2. ANY PERSON HAVING A YARD SALE WITHIN THE CITY LIMITS WITHOUT FIRST OBTAINING A PERMIT AND PAYING THE \$5.00 FEE IS IN VIOLATION OF THIS ORDINANCE, AND IS GUILTY OF A MISDEMEANOR.

SECTION 3. ANY PERSON HAVING MORE THAN TWO YARD SALES WITHIN THE CITY LIMITS WITHIN A YEAR MUST OBTAIN A BUSINESS LICENSE FROM THE CLERK'S OFFICE AT CITY HALL, OR WILL BE SUBJECT TO A FINE.
