ORDINANCE # 15A III

An Ordinance amending the Business License Ordinance to provide adjustments to the business license fee rate table.

BE IT ORDERED AND ORDAINED by the Mayor and Council of the City of Chesnee, South Carolina, in Council duly assembled, as follows:

WHEREAS, under the provisions of Title V, 5-7-30 of the South Carolina code of Laws, municipalities may levy a business license tax on every person engaged in or intending to engage in business, and on businesses based in the municipal limits; and

WHEREAS, the City Council desires to establish a more equitable license fee for the Class 1 (service station) rate; and

NOW THEREFORE, BE IT ORDAINED that the Business License Ordinance is amended as follows:

CLASS 1 SERVICE STATIONS

Each additional \$1000 after the first \$2000 base amount be amended to .25 instead of the present .45.

SEWER RATES

BE IT ORDAINED, IN REGULAR COUNCIL SESSION ASSEMBLED,

That effective with the August 2008 billing, the following rates will be in effect:

TWO MONTHS BILLING

SECTION 1:

INSIDE CITY LIMITS:

First 4000 gallons: \$28. minimum
All over 4000 gallons: 5. / 1000 gallons

OUTSIDE CITY LIMITS:

First 4000 gallons: 40. minimum
All over 4000 gallons: 7. / 1000 gallons

SECTION 2:

All orders, resolutions, ordinances and parts thereof; procedural or otherwise in conflict herewith, are to the extent of such conflict, hereby repealed. This ordinance shall be in effect and in full force until further notice.



ALL OVER 4000 GALLONS: 5.25 PER THOUSAND GALLONS

That effective with the August 2001 billing, the following rates will be in effect:

Two months billing:

Section 1:

All users INSIDE the City limits:

First 4000 gallons: \$16. Minimum
All over 4000 gallons: \$3.50 per thousand gallons

All users OUTSIDE the City limits:

First 4000 gallons: \$30. Minimum
All over 4000 gallons: \$5.25 per thousand gallons
